Key Causal Factors in the rise of TU Safety Reps & their Training

- 1862 disaster at New Hartley Colliery killed 204 miners,
- 1872 Coal Mines Act Workmens Inspectors in the Mines
- 1972 Robens (ex Coal Mines boss) Report on Health & Safety at Work,
 considered TU Safety Reps but rejected them....
- Flixborough Disaster 1974 & Court of Inquiry 1975
- 1977 Legal rights to TU Safety reps and their training by the TUs....following TU campaign.
- Funds from the Government to the TUC,,,which paid......
- Willing tutors from the Workers Education Association, Colleges & Universities to run the 10 day courses.



Flixborough Court of Inquiry, 1975 "Lessons to be learned"

- there was no evidence whatsoever that Nypro placed production before safety. Nevertheless, if production is below target and profit is below budget, there are inevitably conflicting, albeit perhaps unappreciated, priorities when decisions have to be made
- "This corrosion was created because nitrate treated cooling water had been used in the past to dilute small leakages of cyclohexane from the plant.
- This phenomenon had not been appreciated by the management at the time
- it is essential that the management structure should be so organised that the feedback from the bottom to the top should be effective




Structure of the Approach to dealing with Hazards at Work

 Ask the right questions about the nature of the harmful agents/practices/machines etc.

- Via analytical dialogue between S Reps & Tutors sharing the worlds of work conditions, Technical OHS information, and TU organisation aimed at creating "safe workplaces" not lecturing "lazy, greedy, careless, apathetic" workers
- Identify a standard to aim for from the best available information on the world eg USA, Sweden, Germany, Italy, Finland, Russia
- Organise to achieve the standard



Modern Slavery, UK & Globally, 2015

The UK became the third country after Niger and Norway to ratify a landmark International Labour Organisation (ILO) agreement to outlaw forced labour and modern slavery.

The ILO <u>estimates</u> that 21 million people are victims of forced labour around the world, producing approximately US\$150 billion a year in illicit profits.

Modern Slavery In the UK.....

The UK ratification came two days after a West Yorkshire businessman was convicted of employing large numbers of Hungarian men as a "slave workforce" at the now defunct Kozee Sleep bed factory in Ravensthorpe, Dewsbury.

A conviction followed that of Hungarian nationals Ferenc Illes and Janos Orsos, who were jailed last year after being found guilty of supplying Kozee Sleep with slave labour.

Ethical audits by high street retailers including Next Plc, the John Lewis Partnership and Dunelm Mill had failed to spot the exploitative employment practices



Some Lessons of PCBs

- Persistence, bio-accumulation and large spatial range ensures widespread and enduring contamination long after the 1970s bans.
- Action on early liver damage effects in workers in 1930s could have stimulated research and lower exposures
- "The non application of the precautionary principle has left a legacy the total effects and costs of which can only be guessed at"
